USS COD ready for operation

On Saturday March 7th, Fred W8ADW and Clark N8PZD went to the USS Cod to examine equipment that stayed aboard during the winter months. the Robot Color 1200 has been parked in Clark's foyer closet since July 1997 he has hopes of using it to add extra points during Field Day 1998. All appeared to be in good operating condition except the experimental connections to the long wire antenna, Clark sized up the project and prepared a weatherproof feed line to be mounted in place of the connection made early in '97 - the antenna proved to work well on 75/80 and 40 meter bands. Dr. John Fakan is approaching manufacturers to obtain feed lines and control cables to reattach the tower antenna system, Clark has a ham 4 rotator motor to go up on the tower when the weather cooperates. In the meantime Clark fabricated a weather-tite feed line from RG 8 to enhance the long wire antenna operation and was able to secure the connection under the ship company's watchful eye without disturbing any of the submarines delicate components.

The USS Cod will be ready for April 25th, the Submarine Memorial Radio Reactivation net, frequencies and details covered elsewhere in the newsletter.

Submarine Memorial Radio Reactivation:

On April 25 and 26 the radio rooms on as many as 23 memorial submarines will come alive with ham activity. This year's lineup will include the **Torsk** in Baltimore, the **Cod** in Cleveland and the **Growler** in New York City.

The frequencies will be: 3.843, 7.243, 14.243, 21.343 and 28.343 MHz. QSL information will be available on the air.

9N1MM Memorial Station


